The prospective tenderers shall submit technical bid and commercial bid in separate sealed covers which will in turn be placed in larger sealed envelope. The technical bids shall be opened on **05.10.2012 at 02.30 P.M.** in the office of the Chairman in the presence of tenderers or their authorized representatives who wish to be present and after scrutiny of the same, the commercial bids of only those tenderers will be opened who qualify the laid technical specifications. The time of opening the commercial bids will be conveyed to the qualifying tenders later on.

Every tender must be accompanied with separate earnest money @ 2% of the estimated cost or material to be purchased or Rs. five Lakh whichever is more for each item in the form of Bank Draft/Term Deposit or FDR pledged in favour of the Secretary, Punjab School Education Board, S.A.S. Nagar (Punjab). Tender received late or without earnest money shall be rejected.
