Board Level and National Level Awards for Best Entries on Best Practices

The *Rashtriya Madhyamik Shiksha Abhiyan* (RMSA) launched in 2009 envisages to make quality secondary education available, accessible and affordable to all children in the age group of 14-18 years. Several programmes and activities are going on in different parts of India under the RMSA Project.

Contest on Best Practices: Institutions like School Boards and State Councils of Educational Research and Training (SCERTs), State Department/Section looking after RMSA, NGOs as well as persons at their individual level are trying out innovative practices to improve the quality of learning in secondary schools under the RMSA Project or outside of it. On the occasion of the Golden Jubilee Celebration of Maharashtra Board and in the context of COBSE's Annual Conference it has been decided to hold a **Contest on Best Practices** in collaboration with the Maharashtra Board with **the objectives of**

- i) compiling best practices to upgrade the quality of secondary education and disseminating them to various stakeholders
- ii) giving State / Board level and National level recognition to the best entries, and
- iii) promoting the use of out-of-the-box thinking and innovative methods in resolving local-specific challenges

Best Practice means what works effectively in a particular situation or environment to address a pressing issue or challenge. Best Practice may sometimes reveal frugal and home spun solutions involving at times the use of lateral thinking or *jugaad* innovation. In order to make it a research-based or scientifically-based practice, evidence in the form of data and outcome are an essential part. Where scientific evidence is absent or inadequate, professional wisdom needs to be duly recognized. However, it is important to avoid as far as possible personal biases and preferences. It is also agreed generally that what works in a particular situation may or may not work and yield the same results across variety of ground situations obtaining in a country of India's size and diversity. But again the potential for replicability of a practice should be considered a huge plus point for the selection of an entry for an award.

Examples of Best Practices:

- i) Use of CCTV to check use of unfair means in exam
- ii) Innovative use of limited land area in a secondary school

- iii) Innovative use of limited resources in a secondary school to improve the quality of learning
- iv) Introduction of computer-based testing

Criteria for the Selection of Entries for 1st, 2nd and 3rd Positions

- i) Genuineness and Relevance of Issue / Problem to the Quality of Learning / Secondary Education (5 Marks)
- ii) Innovativeness and Uniqueness of the Best Practice (5 Marks)
- iii) Usefulness / Effectiveness of the Best Practice in realizing the desired Outcome / Impact as an evidence (5 Marks)
- iv) Potential for Replicability / Adaptability of the Best Practice (5 Marks)

Total Marks: 20

Who can participate:

- i) Any educational institution / organization working in the area of affiliated secondary schools such as Board of School Education, SCERT, Training College and School (In case of collaboration with NGOs or corporate houses, the entry will be submitted to the Board by the concerned school, not by the NGO or the corporate house. In case of individual teachers / scholars the entry will be submitted to the concerned State Board through a school / institution.)
- ii) Any educational functionary / school teacher working at the secondary school level

Two levels of selection of entries for awards

State Board Level

State Boards of School Education which are members of COBSE will be requested to invite entries from institutions including the Board itself, SCERTs, educationists, schools and teachers in the given format. These entries will be examined by a Committee set up by the Chairperson of the member-Board for the purpose and three best entries will be selected from the area of their jurisdiction for

- a) Board-level Awards, and
- b) Board-level entries for competing at the National Level.

Board-level Awards will be **Rs 10,000/-** for the 1st Position, **Rs 7,000/-** for the 2nd Position and **Rs 5,000/-** for the 3rd Position.

National/ COBSE Level

At the National Level a Committee set up jointly by COBSE and Maharashtra Board will select three entries for

- National-level Awards, and
- Giving their presentations by invitation before the delegates attending the 44th Annual Conference to be held at Pune towards the end of 2015.

There may be scope for other outstanding entries as well to make their presentations in the Annual Conference. The National-level Awards will be **Rs 20,000/-** for the 1st Position, **Rs 15,000/-** for the 2nd Position and **Rs 10,000/-** for the 3rd Position. In addition, the Award Winners at the Board level and National level shall be given **Certificates of Appreciation and Recognition by COBSE.**

Areas on which entries on Best Practices are invited:

- Management and Conduct of Public Examination including its Reliability, any Examination Reform or the Use of Technology to maintain students' record related to the Board Examination or Measures to control and prevent malpractices during examinations
- Assessment of Students in the Co-scholastic / Co-curricular Area under the CCE System
- Integration of Vocational Skills with the Secondary Education Curriculum
- Life Skills Development

- Value Inculcation
- Involvement of Corporate and Industrial Houses, National / International Agencies / Organizations to Upgrade Infrastructure
- Innovative Practice to upgrade Quality of Infrastructure including Toilets and Drinking Water facility
- Community Participation to address issues like the dearth of Qualified Teachers
- Use of IT / Digital Technology to Upgrade the Quality of Learning
- Any Other Area related to Secondary Education

Format in which entries in written form are to be submitted:

- A small paragraph on the profile of the Institution / School or about the person submitting the entry
- State the Issue / Problem / Challenge
- Define the Objective / Goal
- Describe Best Practice including Methodology / Activities to address the issue / problem / challenge
- Describe Participation of persons & institutions in decision-making, planning, and carrying out activities to complete the task
- Demonstrate desired Outcome / Result / Impact Evaluation as an evidence of best practice
- Financial Implications, if any to carry out Best Practice
- The entry should be in the written form comprising about three (3) typed pages (1000 words) with Name / Institution and Address (including e-mail, mobile)
